Hurst Green Neighbourhood Plan Aims, Vision and Objectives Consultation





Introduction

The creation of the Aims, Vision and Objectives for the Hurst Green Neighbourhood Plan used the following local evidence as inputs:

- Evidence #1 Residents comments received at the Neighbourhood Plan kick-off public events
- Evidence #2 Residents comments received on the A21 school route
- Evidence #34 Residents comments received during the Neighbourhood Plan housing demand survey
- Evidence #35 Hurst Green Neighbourhood Plan local housing demand survey
- Evidence #36 Hurst Green Neighbourhood Plan local car parking survey and residents comments
- Evidence #37 Hurst Green Neighbourhood Plan local tourism survey and residents comments

Using the feedback gathered from these evidence documents and a number of public engagement events held throughout 2018 and 2019, a workshop with the Neighbourhood Plan Steering Group was facilitated by our external advisor which enabled the creation of draft aims and a vision for the plan

These drafts were subsequently refined and prioritised by the community at public engagement events held in July 2019, and also via an electronic survey which was widely promoted on social media and the Neighbourhood Plan website.

In the autumn of 2019, a further extended consultation on the aims, vision and objectives was undertaken which saw every household in the parish receive a printed booklet containing the result of 18 months development of the draft aims, vision and objectives. This exercise generated several additional responses, which were taken into consideration in producing the final aims, vision and objectives for the Hurst Green Neighbourhood Plan.

New objectives added

New Business, Economy and Tourism objectives

- Seek to upgrade and maintain sufficient communication networks, and high-speed internet facilities in the village to support the changing nature of employment including an increase in home-working and flexible work spaces.
- Encourage and support the ongoing maintenance of public areas, footpaths, renovation and repair of shop fronts, damaged fences, business signage and notices to further enhance the overall presentation of the village for the benefit of residents, visitors and tourists alike.
- To ensure that all advertising notices are appropriate and do not detract from the AONB by seeking to define an Area of Special Control of Advertisements within the parish.

New Education objectives

• To promote adequate safe car, cycle and disabled parking for those using the school and other educational facilities.

New Sport and Leisure objectives

- Enhancing the existing Drewett's Field sporting and recreation facilities by creating a multi-use all-weather sports area, levelling and improving the existing football pitch, uncovering and repairing the lost tennis courts, installing an outdoor gym, a bike path and an outdoor grass amphitheatre for use by drama groups such as Comedy Capers.
- To investigate the level of interest and possibility of a site for an outdoor bowling green and an associated bowling club.
- Installing public map boards at key locations throughout the parish that show where our public spaces, facilities and key walking routes are located.


New objectives added

New Infrastructure objectives

- Review the current provision for, and enforcement of disabled blue-badge parking throughout the parish.
- Introduce vehicle weight limits on all rural roads in the Parish to avoid HGV's or large vehicles using roads that are unsuitable for them.
- Seek to establish a Doctor's surgery and pharmacy.
- Seek to establish a Dentist's surgery.
- Seek a solution to redirect the excess spring water from flowing down the Bodiam Road.
- To seek to provide locations and the installation of public-access defibrillators in openly accessible (unlocked) cabinets across the parish.
- Seek a solution to the low water pressure often experienced in some parts of the parish.
- Create and install new village signs in Hurst Green, Swiftsden and Silver Hill.








Q3) What is missing or needs changing?






Q5) Do you agree with the Travel and Transport part of the proposed vision? ^{22 responses}




Q6) Do you agree with the Business, Economy & amp; Tourism part of the proposed vision? ^{22 responses}






Q7) Do you agree with the Land and Nature part of the proposed vision? ^{22 responses}






Q9) What is missing or needs changing?


- 1. No chance of a bypass.


Q12) What is missing or needs changing?

Q13) Do you agree with the proposed Education and Training objectives? ^{22 responses}





Q15) What is missing or needs changing?


- 1. How about facilities for older people!


Q18) What is missing or needs changing?






Q21) What is missing or needs changing?

- 4. If you propose to support the return of a community shop, why did you not support the one that we had and subsequently closed?


Q22) Do you agree with the proposed Infrastructure objectives?

Q24) What is missing or needs changing?

- 1. As before, build a bypass.
- 2. Already answered.

Additional Comments (page 1 of 2)

- 1. I think that the proposed roundabouts at Coopers Corner and Station Road will cause traffic to build up through the village and cause excessive pollution and possible gridlock at peak times as well as more accidents due to driver getting frustrated.
- 2. Far more importance should be attached to the elimination of heavy speeding through hurst green. The noise, pollution and vibration is destroying property and causing suffering to the residents living along the A21 through Hurst Green.
- 3. Happy to support the development of Burgh Wood as a volunteer.
- 4. Very supportive of proposed roundabout at Coopers Corner and Station Road. Litter, happy to volunteer. Appreciate the effort put in by local residents to produce this plan, though concerned at its ambition and likelihood to achieve all. Perhaps solve the short term wishes first!
- 5. Very much agree with a good housing mix of good quality and in keeping with the area. There is clearly a need locally for anything between 2 5 bedroom homes.
- 6. We would like to see something more concrete on stopping people parking on pavements.
- 7. Of course, and above all, a "by-pass".
- 8. To promote a bypass will trash a huge swathe of beautiful countryside, harming wildlife in the process.
- 9. Great ideas.
- 10. Bit ambitious?
- 11. How much will it cost? especially for [the] environment, nature, wildlife?
- 12. You should add plant wildlife meadows.
- 13. Quote from Defra 2006: "climate change the most serious challenge facing the world, can only be tackled if we all take action now. The intergovernmental panel on climate change reported... evidence for climate change caused by human activity is stronger than ever... Parish and Town Councils, the first tier of government can play a substantial role... to reduce the risks of climate change."
- 14. In essence Parish Councils can promote and support community initiatives to reduce emissions etc. Possible changes: Low energy bulbs, street lighting powered by wind-chargers. Solar power, Wind power, Biomass.

- 17. This is great community initiative.
- 18. We attended the public meeting, was really good to see parish councillors Brown and Wright and other members of the neighbourhood plan steering group being so passionate about improving the village. Would have been good to see other councillors at the events, presume they are all supportive too?
- 19. I live very near to A21 Coopers Corner, and I feel very strongly that a roundabout at Coopers Corner is urgent as first job as this Coopers Corner causes so many accidents and is a deadly corner and feel worried for my family. Thanks [name supplied].
- 20. All of your proposals sound ideal for Hurst Green. For me personally a roundabout at Coopers Corner is a priority. A pavement along A229 from Coopers Corner would make it safer for residents who have to walk along this road, maybe just a short way.
- 21. My main concern is the need for a roundabout at Coopers Corner as this is absolutely deadly trying to pull onto the A21. I think this is one of the first things needed.
- 22. Like everyone else, desperate for a bypass. Putting that one side we like all the proposals. Parking is a nightmare and parking on the pavements and blocking pedestrians is unacceptable.
- 23. We would like to see better bus services including a Sunday service again.
- 24. Regards housing, the village needs high quality family friendly properties as well as affordable [homes].
- 25. All in all, the document is very positive.
- 26. Depends on Highways England actually caring about our community and safety, can't believe the road surface is already worn less than a year after they attempted to relay it and how fast the cars and lorries travel through the village.
- 27. Coopers Corner was always dangerous and in the last year, perhaps all the extra traffic coming from the new homes in Hastings and Bexhill it has become deadly trying to turn from/on to the A229. Don't East Sussex County Council and Highways England care about safety at all!
- 28. The proposals look very good on paper and describe an idyllic village we would all like to live in, but has affordability been investigated?
